## Additional Information

All students must complete MATH 1110 with a grade of C or better (or receive placement credit) in order to certify the minor.

Econ 1110 or Econ 1120 will count toward the Economics Minor only if credit for the course appears on your Cornell transcript.

- Students who matriculated at Cornell before June 1, 2017 must have grades of C or better in ECON 1110 and ECON 1120 (or equivalents).
- Students who matriculated at Cornell after June 1, 2017 must have grades of B- or better in ECON 1110 and ECON 1120 (or equivalents).

Econ 4990, Econ 4991, and Econ 4999 cannot be counted toward the nine-course requirement.

A course taken to satisfy the ILR Economics Policy Elective can also be counted toward the Economics minor as long as it has an ECON course number (you need not enroll in the ECON number).

Courses in categories (B) and (C), MUST be taken at Cornell.\*\*\*

At least five of your 3000-level or higher Economics minor courses must be taken at Cornell\*\*\*. The only exception is if you participate in a Cornell-sanctioned two-semester Study Abroad program, in which case at least four of your 3000-level or higher Economics minor courses must be taken at Cornell\*\*\*(with at most at two non-Study Abroad courses at another university). (Note: To obtain Economics Minor credit for courses taken away from Cornell, including Study Abroad, you must get approval from the Director of Undergraduate Studies.)

\*\*\*Note: Economics courses taken through Cornell Winter Session, Cornell Summer Session, or Cornell in Washington count as being taken at Cornell. Economics courses taken in a Cornell-sanctioned Study Abroad program or at another university, do NOT count as being taken at Cornell.

For students who transfer into Cornell with advanced standing:

For requirements (B) and (C), Economics courses taken at your previous institution prior to your enrollment at Cornell and approved by the Director of Undergraduate Studies to count toward the Cornell Economics minor will count as being taken at Cornell.

For courses taken in categories (B) - (D), at least two must be taken during Cornell regular sessions, Cornell Winter Session, Cornell Summer Session, or Cornell in Washington. Please note that Economics courses taken at your prior institution do not count toward this requirement.

Certification of Minor: Before you graduate, the Director of Undergraduate Studies must certify to the ILR Registrar that you have completed the requirements for the ILR Economics minor. For instructions, see the Undergraduate Economics website.
